Welcome! We are pleased that you want to become a part of our store. Here is how it works:

- Once your items have been approved for consignment we will eagerly await their arrival.
- We base our prices on supply and demand. We will get the best possible prices for you.
- You will receive **50%** of the selling price. A 3% fee will be deducted for credit card transactions. Checks are ready on the 15<sup>th</sup> day of the month for all items sold during the previous month. Please drop in any time after the 15<sup>th</sup> to pick up your check and see what's new. Checks will be automatically mailed on the 20<sup>th</sup>.
- The 120 day period begins once the item is placed on the showroom floor. The selling price will be set at a reasonable rate as to be able to offer up to a 20% discount should that be the necessary enticement to get the item sold. If the item has not sold after 30 days it will be reduced by 20%. The item will be reduced by 20% every thirty days with a maximum of 3 consecutive markdowns. Your items will remain on display for 120 days. At the end of the contract period we will re-evaluate the potential of the consigned items.
- After 120 days, you will have ten days to pick up your items. Upon request, items that are unsold at the end of 120 days will be considered for re-consignment based on space availability and realistic continued marketability. You may also choose to have your items sent to auction however that is a separate agreement that will require written confirmation by you. If we don't hear from you within the ten days following the end of our agreement, all items will become the property of *Hunt & Gather, LLC*. for disposal and all proceeds will be paid to *Hunt & Gather, LLC*.

**Please initial that you understand and agree that if you do not make arrangements to pick-up your items within ten days following the end of the contract period, your items will become the property of *Hunt & Gather* for disposal.** \_\_\_\_\_

- We will do our best to safeguard your items, but we are not responsible for damage or loss.
- **The items consigned cannot be advertised or sold in any other way until the end of the contract. This includes being sold to individuals via internet, email, or personal conversation.
